**Visioning in Textiles & Mixed Media** is an applied design and color workshop for textile and mixed media artists. The goal is to cultivate the forward movement of your artwork in the direction that YOU desire. The learning tools include hands-on experimentation with design, color, and a few useful mixed media. Individual consultations provide an opportunity to address your specific themes and goals, offer gentle guidance in your art process, and sharpen your focus. Class conversations teach you how others see your work – and how you see theirs.



This retreat is a great opportunity to stimulate your creative juices and find your vision to progress in your artwork.

### **Daily Themes**

Day 1 (Monday) - Visualize Design, Value Structure, Focus, Mixed media materials introduction.

Day 2 (Tuesday) –Passage, Edges, Create Impact with Color (Chromatic, Achromatic colors, and Neutrals) Day 3 (Wednesday) – Balance, Rhythm, Movement, and Direction, Textural Contrast, a Unique Advantage of Textile Work.

Day 4 (Thursday)- Subtlety and Drama, The Power of Intent

**Shared Materials** - A Class Treasure Chest containing fabric and thread in a range of colors. Use these for making samples, experimenting, and play. Also included are several useful mixed media materials and tools that will be shared by the class.

**Pre-Work** Gather the following items and supplies. Please allow yourself plenty of time to curate your collection. Bring one suitcase to class containing:

- 1. Your ideas for one or two future works notes, drawings, images
- 2. Sketchbook or notebook, writing/drawing/coloring tools that you enjoy using
- 3. Your usual materials of choice such as fabric and threads if you create work in many different techniques, please choose one or two current favorites
- 4. Scissors for embroidery, fabric, paper, and metallic threads
- 5. Straight pins, pink hair tape, or other ways to join materials temporarily
- 6. Needles that you use most often, some sharp needles, some tapestry needles
- 7. A few and stitching threads ranging from thin to thick. Focus on one or two colors and neutrals.
- 8. Optional artworks that cause you uncertainty or blockage. These are often works that you have put aside for a time. You can bring photos if space is limited.
- 9. Optional attachments that you enjoy beads, buttons, keys, found objects
- 10. If you wish, you may bring additional items to store in your room or car trunk.



**Laura Smith** is an embroidery innovator, nationally known designer, and teacher. She holds the Master Craftsman in Color from the Embroiderers Guild of America (EGA) and has won their National Gold Thread Award for service in 2021. She has served as chair for the EGA Master Craftsman in Color Program from 2006 – 2018, Chairman of Fiber Forum (2011 – 2015) judge for a Master Craftsman program (2015-2023), EGA National Education Exhibition Chairman (2017), seven terms as president of her chapter, and has held every chapter office. Laura is a former Executive Director of an arts center with responsibility for over forty successful exhibitions, fourteen artists/teachers and their classes, numerous community events, public

relations, grantsmanship, and fundraising. She holds an MBA as well as an undergraduate degree in chemistry – valuable for understanding paint and mixed media materials.

### Marywood Retreat & Conference Center

Our retreat will be held at the Marywood Retreat and Conference Center, just 39 miles from the Jacksonville International Airport. It rests on 100 acres of tranquil surroundings that are accented with towering live oak trees and gardens. Three meals a day are provided in a dining room with views of the St John's River. The sleeping rooms include a private bath, and are roomy, comfortable, and contained within a charming villa. In addition, our villa will include a lounge with a full-size refrigerator and coffee pots. Our classroom is large and airy with an individual
